This chart provides information about rider education programs in states which have legislated programs. The Legislative Provisions section only includes major provisions included in each state's law as of November 2010. Many state laws have additional provisions. State agencies also may have adopted administrative rules, regulations or standards. It is necessary to refer to the actual laws and regulations for complete

program information. The Department of Defense has also adopted motorcycle safety guidelines, including requiring motorcycle rider training, for all four military services, as has the U.S. Coast Guard.
